North Central Arkansas Workforce Development Board – Meeting Minutes 6-13-18

The North Central Arkansas Workforce Development Board convened for its quarterly meeting on June 13, 2018 at the University of Arkansas Community College in Batesville. The meeting was called to order at 10 a.m. by Chair Pam Williams.

The next agenda item was presented by Karla Rush. Ms. Rush discussed the process involved in updating four policies (Work Experience, Individual Training Account, Procurement, and Supportive Services for Youth and Adult/Dislocated Workers). Rush explained the updates were in compliance with state recommendations and the intent of the local workforce development board's mission. With a motion to approve all policies as presented from Ben Baxter seconded by Angela Ryland, the motion passed unanimously.

A financial report was provided by WRPDD accountant Byron Southerland and program updates were given on one-stop operations and core partners by Karla Rush, NEG program by Angela Goodwin and WIOA participation by Donetta Bradford.

After introductions of visitors and members, Chair Williams invited comments from special visitor Arnell Willis, Arkansas Department of Workforce Services Director. Willis discussed the barriers for job seekers, the interest of regional workforce leadership to create strategies to serve target populations and upcoming performance measures for Arkansas' workforce boards. Director Willis stressed increased business services, funds utilization rates, increased services to ex-offenders and to target populations with fourteen specific barriers to employment. Board members engaged in question/answer time with Director Willis.

Chair Williams asked the board members to think about potential educational initiatives and training topics for upcoming meetings.
